

ICAR-CIWA concluded Vigilance Awareness Week - 2017

ICAR-CIWA Bhubaneswar observed Vigilance Awareness Week- 2017 w.e.f. 30th October, 2017 - 4th November, 2017. The theme of the Vigilance Awareness Week was " MY VISION - CORRUPTION FREE INDIA ". Banner of Vigilance Awareness Week was displayed at prominent locations in Office and Main gate. Celebration of the week was commenced on 30th October with the Integrity Pledge administered by Dr.(Mrs.) Jatinder Kishtwaria, Director, ICAR-CIWA to Officials and Staff, RA/SRF/ Service provider/Contractual including Officials of Govt departments of 8 states participating in the ongoing Model Training Course . More than hundred persons participated and taken the Integrity Pledge.

Dr. S. K.
